In consideration of this permission, and for other good and valuable consideration the receipt and sufficiency of which is acknowledged, I hereby agree to forever RELEASE from any and all liability, discharge and agree not to sue, Orion Art Center, The Village of Lake Orion, Charter Township of Orion, GWN Dragon Boat Racing, Lake Orion Lake Association, All Event Benefactors, All Power boat owners & operators, All Event Participants, All Event Sponsors and their respective directors, members, trustees, agents representatives, officers, sponsors, licensors, servants, employees, and authorized representatives hereafter referred to as "the Organizers" and agree to hold and save them HARMLESS AND INDEMNIFY them from and against any and all liabilities, claims, injuries, losses, damages, expenses, demands, actions, and causes of action of whatsoever kind or nature arising out of or related to any such loss, damage, or injury, including death, etc. that may be sustained by me for whatever reason while participating in or upon the premises leased, permitted, supervised, or controlled by "the Organizers" and their respective directors, members, trustees, agents representatives, officers, sponsors, licensors, servants, employees, and authorized representatives for such damages or costs associated therewith incurred by me. I understand and agree that the event maybe cancelled, changed, or adjusted due to conditions beyond the control of the organizers. These conditions include water level, current, weather, as well as the safety of participants. The cancellation, change or adjustments is at the sole discretion of the "Organizers" and that the team or I will not receive or seek a refund of any fees paid or costs incurred. I also agree to release and discharge forthwith on the request of "the Organizers" and their respective directors, members, trustees, agents representatives, officers, sponsors, licensors, servants, employees, and authorized representatives each and every obligation or claim which shall be made, assigned or apportioned against "the Organizers" and their respective directors, members, trustees, agents representatives, officers, sponsors, licensors, servants, employees, and authorized representatives by any party by virtue of any injury or damage caused by me absolutely.

I and my next of kin are duly aware of the risks and hazards inherent in the preparation and participation in the Dragon on the Lake - Lighted Boat Parade. Participating in said events, knowing conditions may be hazardous and dangerous and that obstructions may exist, and I hereby voluntarily assume all risks of loss, damage, or injury, including death, that may be sustained by me or any of my boat participants to any property while in or upon said premises or engaged in said event. I agree to abide by and follow all rules of participation as published and/or expressed.

I am aware that the Dragon on the Lake - Lighted Boat Parade could involve a large measure of physical exertion, risk for electrical safety and so should not be attempted by anyone with health conditions that may be affected by such physical exertion or do not exercise safe practices or take necessary precautions to assure safety of self or others. By signing this document, I hereby certify that I accept all responsibilities for any damages or injuries that may be incurred by myself or any of my boat participants in the preparation or participation in the Dragon on the Lake - Lighted Boat Parade including any activities following the Dragon on the Lake - Lighted Boat Parade.

In signing the foregoing release, I hereby acknowledge and represent, that I have read the foregoing release, understand it and agree to it voluntarily, that I am 18 years of age or older, and of sound mind, or will be 18 years of age prior to December 31 of this year and I have co-signed with a parent or guardian, as the case may be. Proof of age may be required.
